Plan, build, promote and maintain the Bay Area Ridge Trail. When complete, the Ridge Trail will extend 550 miles and connect over 75 parks and open space preserves in the 9-county Bay Area. At the end of 2015, 365 miles were dedicated. Trail dedications in 2015 totaled 12.6 miles, including: East Slope Sonoma Mountain, Garin-Stonebrae Trail, John Nicholas Trail, North Slope Sonoma Mountain, and Presidio Battery Marcus Miller Bridge Trail. In 2015, the Council hosted 8 marquis supported trail events all around the region, including Ridge to Bridge in Marin and San Francisco, a 5-day East Bay Hills Thru Hike and Ride, and the REI - Ridge Trail Service Day for over 1,585 participants. The Council participated in another 12 community outreach events. Over 1,200 volunteers provided about 4,500 hours of volunteer service on trail care and supported outings and events.
