Plan, build, promote and maintain the Bay Area Ridge Trail. When complete, the Ridge Trail will extend 550 miles and connect over 75 parks and open space preserves in the 9-county Bay Area. At the end of 2017, 375 miles were dedicated. Trail dedications in 2017 totaled 6.8 miles, including: Mount Umunhum and Mount Sutro. In 2017, the Council hosted trail events all around the region, including Ridge to Bridge in Marin and San Francisco, a 5-day East Bay Hills Thru Hike and Ride, and the REI - Ridge Trail Service Day. Over 1300 people hiked, biked, and rode with Ridge Trail outings leaders in 2017, and 550 volunteers provided about 3,206 hours of service on trail care and supported outings and events.
