Plan, build, promote and maintain the Bay Area Ridge Trail. When complete, the Ridge Trail will extend 550 miles and connect over 75 parks and open space preserves in the 9-county Bay Area. At the end of 2018, 375 miles were dedicated. In 2018, the Council helped open 7 miles of trail to mountain bikes, re-signed 350 miles of trail and improved drainage on over 12 miles of trail. The Council hosted trail events all around the region, including Ridge to Bridge in Marin and San Francisco, a 5-day East Bay Hills Thru Hike and Ride, and the REI - Ridge Trail Service Day. Over 2000 people hiked, biked, and rode with Ridge Trail outings leaders in 2018, and 400 volunteers provided about 2,125 hours of service on trail care and supported outings and events.
